Our holistic approach benefitted 581 boys and girls from 13 public elementary and high school schools that we adopted. The elementary school beneficiaries were provided with one meal everyday to improve their nutritional condition. All beneficiaries are provided with their other school needs such as uniform, bags, socks, notebooks, shoes, etc. We conducted livelihood projects for the parents to improve their financial status. We also conducted training for teachers to improve their teaching skill. We also supported a number of poor but deserving college students.

We have built and donated libraries; repaired and renovated classrooms; and donated playground facilities.

We hope our efforts contribute to narrowing the income gap among our people by lessening the financial burden of our poorest families.

The funding for the foundation come mostly from companies belonging to the La Filipina Uy Gongco Corporation Group of Companies. We are encouraging public awareness and support by campaigning for donation for specific projects via fun run and other activities.

We thank companies and individuals who share our vision and mission and have contributed money, materials, and services. There are still a lot of children who need help. We hope more companies and individuals will lend their helping hands in building a more equal, more enlightened nation.






# Generosity in its\_true nature

Activities such as: a guitar sing along was prepared in music; egg shell mosaic, crayon blowing, scrapbook making and string pulling in arts; and in sports, there was badminton and dodge ball.

It is indeed rewarding to see a child learn new things, and blossom into an innovative and inventive person. Experiencing different situations and activities will certainly prepare the child to face the challenges in the future.








# **Getting ready**

Every school year, students expect to have a fresh start. What better way there is than to start building it first within yourself? This summer, in the month of May, the foundation conducted a unique Medical Mission to its adopted elementary schools for the opening of the new school year.

The UFI's Medical Mission:

- "Alis Kuto" removal of lice from the child's hair/head with the use of lice shampoo. Volunteers from UFI, Philippine Foremost, LFUGC, and Amigo Terrace Hotel spared their time in helping out in the activity.
- "Kontra Bulate" deworming activity for all UFI beneficiaries wherein deworming medicines where given by medical student volunteers from Stella Juris Sorority, Scintilla Jvris Fraternity, and Order of Asclepius as well as DepEd.
- "Linis Tenga" cleaning of the children's ears through soaking the ear canals, and then flushed with water with the use of a needleless syringe, to rinse out the dirt. This was again done by medical student volunteers.
- "Linis Kuko" cutting and cleaning of nails, both in the hands and feet of the children, done by our UFI parents who were cosmetology graduates from Ang Horteleza Foundation, Inc. our partner in our skills training program.
- "Gupit Buhok" wherein the children's hair were cut and/or trimmed to neatness for them to have their new looks in preparation for the new school year. This activity was also done by our UFI parents.

After the event, the only thing parents need to worry about is maintaining their child's neatness and new aura as much as they can. One that is very much manageable, we believe.





# A "MEAL" A Day Makes the Children in School Stay

UFI's Feeding Program started to implement the Uniform Feeding Menu wherein all 8 feeding schools will have the same kind of food everyday. UFI prepared the menu with the recipe based on the previous dishes that the school and the parents had been cooking with the help of a nutritionist. Nutritious recipes were also made that could help in the nourishment of the children. The parents also have an easier time preparing the dishes because they will just follow the manual.

UFI's Feeding Program provided the beneficiaries with a single daily meal marketed and prepared by the parents of the beneficiaries in the adopted elementary schools. These blessed schools were composed of eight public elementary schools, 5 located in Iloilo City, 1 in Guimaras and 2 from Capiz with 301 feeding beneficiaries.

A very thoughtful and accommodating plan since students would normally skip breakfast or would have no breakfast at all and would wait until lunch before actually getting their stomachs full. Not only does this lessen the burden of parents providing for their children's meals, but it also gives them an assurance that the children will be properly fed without a hitch under their own guidance and expertise.

Teachers from the adopted schools expressed relief in the decrease of absences from the beneficiaries due to the assurance of one full meal everyday including summer. Parents are more confident now that their children can eat a balanced meal.









# "I need help to go to school..."

For this year, UFI's Scholarship Program for Basic Education once again never failed to provide aid to its scholars. School supplies, bag, umbrella, school uniform, school shoes, socks, payment for miscellaneous fees, groceries with personal needs and rice were provided to the 381 elementary and 200 high school beneficiaries located in Iloilo City, Guimaras and Capiz.

School supplies, bags and umbrellas were given last July when enrollment in school nearly ends and classes were in full swing. School uniforms with shoes and socks followed by September. Miscellaneous fees were paid directly to the schools. Additional school supplies came by November. Groceries and personal needs pack for each beneficiary were given by December. And the rice subsidy followed by March before the closing of the school year.

All 581 beneficiaries, together with their families, greatly benefit from the yearly scholarship grant as long as they maintain the general average of 75% or better for elementary and 80% or better for high school at the end of every school year.

Parents express great relief for the provision of these goods. Teachers' worries were also lessened because the children now have the basic things to use in school that can help them in their studies.

# In Support of the Other Side of Basic Education

Year 2012 brought some sort of enlightenment to the understanding of Alternative Learning System, commonly known as the non-formal or the other side of the basic education. There are various types of ALS and each of the adopted high schools has its own adaptations with variations that complement the different needs of the school.

The Alternative Learning System has different Programs: The Accreditation and Equivalency Program (A & E), ALS Mobile Library, eSKWELA Project, Informal Education (InfED), and BP-OSA (Balik Paaralan Para Sa Out of School Adults) among the numerous types that are listed and implemented in the different school all over the country.

In response to the common needs of the ALS as verbalized by the adopted high schools, UFI provided one (1) unit laptop for the use of the ALS Moderator. These laptops were donated by Coca-Cola through the Association of Foundations (AF) where UFI is one of the active member. In addition, six (6) desktop computers for each school were also given for the use of the ALS students. The desktop computers were installed with Windows 7 operating system making them ready to use. This was in support of the eSKWELA of ALS.

The lucky recipients were Fort San Pedro National High School, Jalandoni Memorial National High School and Buntatala National High School.









# **Aiming Higher**

The foundation does not only limit its educational aid to the basic education level but it also caters to the tertiary level. The scholarship is for the tuition, other school fees, and allowance for the duration of the program of study taken by the scholar. What is unique in this program is that: once one graduates as an Uygongco Foundation, Inc. scholar he or she is already assumed of employment for the next 2 years after graduation. The scholar will be a part of the LFUGC group of companies.

UFI's scholars, under the program, are fresh high school graduates that are about to enroll in their freshmen years in college. It is a rotational cycle for each year wherein the first batch being the children of company employees, the second batch, are children from the host communities of LFUGC, and the third are children of government employees. These scholars, enroll in different Bachelor Degrees or vocational courses according to the list of courses needed by the company. They are required to have a minimum weighted average grade of 2.5 or better and a grade point average of at least 80%. In the course of their scholarship, they are also entitled to various activities given by the Foundation, one of which are formation sessions and volunteerism during summer. For 2012, the scholars were given sessions on Time Management and First Aid and Basic Life Support.







Under the program, at present, are 12 regular UFI scholars who are in the different colleges and universities.

The foundation is looking forward for another batch of scholars from its company employees this coming school year 2013-2014.

## Education Doesn't Have to End in School

Graduation or having a job does not mean the end of education. Life is a continuous process of learning, because the world itself is dynamic; it is prone to change. We all need to constantly improve ourselves as time asks us to do so.

UFI's Mentoring the Mentors Program, in partnership with the Foundation for Worldwide People Power, Inc. and Marie Eugenie Institute, Inc., did just that as two training sessions were successfully conducted. The first 3-day group were participated by 60 participants, having 20 teachers each, from Rizal Elementary School, Jordan Central School and Jordan National High School held last May 31 to June 2, 2012. As on the second 3-day group, they were a total of 65 Day Care Workers coming from Molo and Arevalo Districts. Indeed the days were fruitful for the teachers as they were able to further enhance their skills and abilities in their field of teaching and nurturing of young minds.

As the theme goes, "Education Revolution" - were the fundamentals of education is simply not enough, rather going beyond the call of duty as the most vital aim for learning.

# Let's Get Some Skills and Earn by Will

The Livelihood Training Program of UFI features three courses for both parents and teachers. In March, there was a three-day Cosmetology Training given by Ang Hortaleza Foundation, Inc. with 35 parents from Jordan Central School and Jordan National High School. They were taught how to apply hot oil treatments, cut and put highlights on the hair, foot spa, and manicure and pedicure.

On the month of May, 30 participants were taken for (WVCST) Western Visayas College of Science and Technology's extension program on Sewing. It was a three-day training on how to sew bandanas, aprons, graduation caps and togas, as well as "katcha" bags made from flour sacks.

Lastly, in October, 16 parents and teachers participated in an intensive 10-day training session on baking at Philippine Foremost Milling Corporation. Baking equipment, materials, and ingredients were a given to the schools for them to start their own income generating project. They were able to bake breads and cookies to cakes and certain kinds of desserts.

The program was such a success that the parents and teachers were much grateful for their experience. Parents or mothers were able to earn from foot spas and manicures and pedicures; while schools were able to have added income from baking new treats and selling them in their respective cafeterias or canteens, and others from renting out their own sewed togas and uniforms. Teachers also benefited from the experience as they were able to teach what they've learned in their TLE (Technical Livelihood Education) - class.







# Running to Help Build A Library of Hibao-an Elementary School

The 3rd LFUGC Fun Run held last October 14, 2012 was handled and spearheaded, for the first time, by Uygongco Foundation, Inc.

As it was a fund raising event to help build a library for the adopted schools of UFI, it was also an event to foster camaraderie among the employees of the La Filipina Uy Gongco Group of Companies. In relation to the purpose of the event, UFI had capable and willing hands of the Human Resource Office and employees of Philippine Foremost Milling Corporation, La Filipina Uy Gongco Corporation and Amigo Terrace Hotel & Mall to help out in all the undertakings.

The event had a 5km run and a change of route unlike the past two Fun Runs. This time, the route used the main roads of Iloilo City while starting and finishing at Amigo Hotel parking lot.

The registration fee was Php150. Singlets, donated by ICCHS Batch '82, were also sold.

Winners were given cash prizes plus medal and tokens from UFI with a package of introductory products of Amigo pasta and La Filipina canned goods.


The LFUGC Logistics Department won a special trophy with the most number of registrants coming from their department.

# Provision of Facilities and Instructional Materials to Aid the School, the Teachers and the Students

Education would not be complete and as effective if it lacks the necessary equipment and materials to function proficiently. How can one teach without the proper tools; and how can one learn without the proper facilities? Good education requires all the essential utilities it needs in order to serve its main purpose – teaching the children. UFI's Instructional Materials Improvement Program and School Facilities and Classroom Furniture Improvement Program provide its adopted schools with the basic and updated facilities and instructional materials they deserve in enhancing more of their learning in school. In addition, there is the renovation or enhancement of school playgrounds to give balance to both academic and non-academic activities, and because playtime is a need for every child's development.

Since education is the primary concern of the Foundation, libraries were also provided to the schools. The construction of these libraries was made possible through the UFI's fund raising activity by organizing fun runs. Aside from the libraries, there were also rehabilitation of classrooms, fixing of roofs, ceilings and windows; magnetic chalkboards were also given for the easy placement of visual aids and comfortable writing; the restocking of armchairs and teacher's table; audio visual facilities, projectors with screens and whiteboards.

These were provided for improving the quality of teaching and learning in the 13 adopted schools, because a sound environment can bring better focus and concentration to the students' learning ability. That is why it is important to provide the ideal atmosphere for the students' center of learning.

#### INDEPENDENT AUDITOR'S REPORT

The Board of Trustees Uygongco Foundation, Inc. Amigo Terrace Hotel & Mall Delgado, Iznart Streets Iloilo City

I have audited the accompanying financial statements Uygongeo Foundation, Inc. (a non-stock, non-for-profit corporation) which comprise the statements of financial condition as at December 31, 2012 and 2011, and the statements of activities and fund balances and statements of cash flows for the period then ended, and a summary of significant accounting policies and other explanatory notes.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Philippine Financial Reporting Standards for Small and Medium Entities This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Philippine Standards on Auditing. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.
